

## **2025 Hilario Galindo Program Information Guide**

This document provides a brief overview of what to expect when serving on an HHG team in Guatemala. Please also read the **Volunteer FAQs** prior to completing your application.

Faith In Practice may deem it necessary to adjust the guidelines as needed during the year. Thank you for your flexibility, understanding, and willingness to work within these parameters.

## **Staying Healthy**

Faith In Practice strongly encourages all volunteers to be current with the vaccination schedule outlined by the CDC, including routine flu and pneumonia vaccines. The CDC has extensive and valuable information related to travel in Guatemala, and Faith In Practice encourages all volunteers to review this site. Faith In Practice also urges all volunteers to consult with their personal physicians for specific, individual advice regarding medical precautions.

Please review the **Illness During Mission Protocol (IDMP)** for additional information that outlines expectations and steps to be taken when a communicable illness may be present among the FIP staff, US volunteers, or Guatemalan volunteers during a medical mission

#### Recruiting

Faith In Practice Hilario Galindo surgery team leaders will elect to operate out of up to 4 operating rooms. Team size: 30 - 40 U.S. volunteers (max capacity team size is 40 U.S. volunteers).

#### Roles to recruit:

- Surgeons: 3-5 (based on specialties you plan to bring to staff up to 4 ORs)
  - Primary/Lead surgeons are required to have a minimum of 5 years' experience in their surgical field specialty.
- Anesthesia team: 3-5 (at least 2 must be MDs and there must be one more anesthesia provider than number of rooms you are planning to bring)
- Scrub techs/nurses: 2-4
- Nurse Circulators: 2-4
- OR Director: 1
- Post-op/PACU: 2-4
- Convalescent Ward Physician/NP: 1
- Pharmacist: 1
- Clergy: 1
- Photographer/blogger: 1 2 (can be filled by one person)
- Translators/interpreters: based on Spanish proficiency of the medical professionals.
- **Mobility Clinic**: In 2025 all Hilario Galindo surgery teams will have a mobility clinic component and all team leaders should plan to recruit the following roles for the mobility clinic.
  - o 2 PTs/OTs
  - o 1 Medical Provider (either MD or NP)
  - o 2-3 Assemblers
  - o 0-3 interpreters, based on the Spanish proficiency of the PTs/OTs and medical provider.

#### Roles to NOT recruit:

- Pre-op nurses. HHG staff will be providing pre-op care for the patients.
- Dental Providers: We will not have a dental component on our Hilario Galindo teams in 2025.

Specialties within our current scope of care at Hilario Galindo:

- General Pediatrics
- GEN
- URO
- GYN
- ENT

### **Personal Protective Equipment (PPE)**

Face masks are required to be worn at all times in the ORs at the hospital. The most up-to-date protocols will be provided to you and the team during your team orientation in Guatemala.

## **Supplies & Medications**

It is critical the team leaders and medical professionals on the team review the Medication and Supply lists of items that Faith In Practice will provide for each surgery team. It is the team's responsibility to determine what additional medications and/or supplies are needed for the specialties you plan to bring during your mission week. If there are items your team needs that are not provided in the medication and supply workbook, we ask for the team to procure the items to bring with them for the trip.

The **2025 Medication and Supply list** for surgery teams will be available in the fall of 2024. The information will be listed on the Faith In Practice website at <a href="https://www.faithinpractice.org/volunteer">https://www.faithinpractice.org/volunteer</a> resources/.

Our surgery program staff will connect with the team leader, three to four months prior to the mission week to set up a call to discuss in detail the medications, supplies, and equipment the team will need for the mission week. Anesthesia Directors, OR Directors, pharmacists and other team members may be asked to join these calls.

## **Flights and Travel Requirements:**

A visa is not required for U.S. citizens entering Guatemala. Your U.S. passport must be valid at the time of entry and exit out of Guatemala. We recommend having a minimum of 6 months validity on your passport when you enter Guatemala. For the most up to date information on US passport information to enter Guatemala, please visit the Travel.State.Gov website for travel to Guatemala.

If your passport is from a different country, please check with your state department on requirements to enter Guatemala.

We ask volunteers **to not book flights** until they are officially added to the team in the database and receive a confirmation email stating that they have been added to the team.

It is very important for team members to make every effort to arrive to Guatemala on the team flight or on a flight that is within the same timeframe. Faith In Practice is not able to support multiple pickups from the airport or arrivals prior to the mission week. Hilario Galindo teams arriving on Saturday must arrive by noon for transportation to Reu.

When leaving Guatemala, team members should depart on flights within the same timeframe and ride the team bus to the airport. In the event that a volunteer is unable to depart with the team on the departure date due to geographical limitations or limited flight options, Faith In Practice can set up individual transportation for a team member for an additional fee.

Volunteers extending their stay in Guatemala are required to make their own proper accommodations. Faith In Practice is not responsible for arranging accommodations or financially contributing to arrangements outside of the official team dates.

### Hotel/Lodging

There will be double occupancy rooming during the mission week. Each U.S. volunteer can expect to have a roommate during the mission week.

#### **Ground Transportation**

We continue to work with many of the same providers and some new providers.

Public Health regulations regarding public transportation, including shuttle buses, will be occupied full capacity.

All team members must be on team transportation.

#### We will strive to keep these Information Sheets updated.

Please note that the situation remains fluid and flexibility is important.

In any situation where Faith In Practice and Guatemalan law and regulation are in conflict,

Guatemalan law and regulation will supersede.
